


2023 Financial Report

Mission of ASF

To provide financial support to families battling childhood cancer in the Inland Northwest while raising awareness of this disease.

When a child is diagnosed, **the family is diagnosed.**



In February 2021, Heidi was diagnosed with a brain tumor at 3.5 years old. Just two days after diagnosis, Heidi had surgery- only a portion of her tumor was able to be safely removed. Heidi then completed two years of a targeted chemo to treat the remaining part of her tumor. Over the years Heidi has had to have a feeding tube, physical, speech, and occupational therapy, spending many hours in appointments with multiple specialists in Spokane and Seattle. While Heidi's tumor is stable, she is still required to go to Seattle every three months.

"The Anna Schindler Foundation has helped support our family from the very beginning. Within minutes of Heidi being transferred to her room in the PICU of Sacred Heart we received our first meal card. Polly sat with us as Heidi was in surgery. The foundation continues to help with travel expenses to Seattle." - Heidi's mom. Thank you for your generosity in supporting families like Heidi's during their child's cancer treatment!



Anna's Homes

On March 25th, 2024 we broke ground to commence construction on four more individual-family townhomes for families traveling to Spokane for their child's intensive cancer treatments. When complete, Anna's Homes will be able to serve up to six families at a time, tripling our previous capacity! Families stay at Anna's Homes at no cost to them, thanks to donors like you.



From the Treasurer

During 2023, the Anna Schindler Foundation once again achieved a year of record results. Our generous donors continue to support us in our mission of directly supporting childhood cancer families through financial assistance as well as housing via Anna's Homes. In addition, allowing us to further build our resources for construction of Phase II of Anna's Homes, which will provide four additional units to out-of-town families needing housing nearby to Sacred Heart Children's Hospital. **Occupancy at Anna's Homes continues to average over 90%.** Construction is expected to commence mid-2024.



During 2023, total revenues and donations from all sources grew to over **\$694K**, up almost 10% from the prior year. This was the result of continued growth in our donor base as well as an incredible show of support for our two fundraising events - the Anna's Homes Gala and the Annual Golf Tournament. Funds used for the direct benefit of childhood cancer families during the year totaled to a record **\$220K**, averaging to over **\$18K/month**.

ASF entered 2023 with no debt and a strong cash position and continued to improve on this position, ending the year with **\$634K** in cash reserves, the majority of which is planned to be used for construction of Phase II of Anna's Homes.

We continue to operate with a modest paid staff (one full time / two part time) and over 50 volunteers which help coordinate our events and donor relations.
